

COVID 19 - WAIVER & LIABILITY

HD DANCE INC WAIVER OF LIABILITY, AND INDEMNITY AGREEMENT

IN CONSIDERATION for being permitted to utilize the services, and programs of HD DANCE INC and/or for my children listed above to so participate for any purpose, including, but not limited to, observation or use of facilities or equipment, or participation in any off-site program affiliated with HD DANCE INC. The undersigned, on behalf of himself or herself and such participating children and any personal representatives, heirs, and next of kin (hereinafter referred to as "the undersigned") hereby acknowledges, agrees and represents that he or she has inspected and carefully considered such premises, equipment and facilities and/or the affiliated program and that the undersigned finds and accepts same as being safe and reasonably suited for the use or participation by the undersigned and such participating children.

In addition, the undersigned acknowledges that novel coronavirus ("COVID-19") infections have been confirmed throughout the United States, including several cases in California. In accordance with the most recent guidance and protocols issued by the World Health Organization (WHO), the Centers for Disease Control and Prevention (CDC), the California Department of Health (CDH), for slowing the transmission of COVID-19, the undersigned hereby agrees, represents, and warrants that neither the undersigned nor such participating children shall visit or utilize the facilities, services, and programs of HD DANCE INC (other than any exclusively online services and programs) within 14 days after (i) returning from highly impacted areas subject to a CDC Level 3 Travel Health Notice, (ii) exposure to any person returning from areas subject to a CDC Level 3 Travel Health Notice, or (iii) exposure to any person who has a suspected or confirmed case of COVID-19. The CDC Travel Health Network is continuously updating this list and the undersigned agrees that they are aware of this list and the countries listed. The undersigned agrees to check the CDC Travel Health Notices list

(https://www.cdc.gov/coronavirus/2019-ncov/index.html) prior to utilizing the facilities, services, and programs of HD DANCE INC, on a daily basis if necessary. The undersigned hereby agrees, represents, and warrants that neither the undersigned nor such participating children shall visit or utilize the facilities, services, and programs of HD DANCE INC if he or she (i) experiences symptoms of COVID-19, including, without limitation, fever, cough or shortness of breath, or (ii) has a suspected or diagnosed/confirmed case of COVID-19. The undersigned agrees to notify HD DANCE INC immediately if he or she believes that any of the foregoing access/use restrictions may apply.

HD DANCE INC have taken certain steps to implement recommended guidance and protocols issued by the Public Health Agencies for slowing the transmission of COVID-19, including, without limitation, the access/use restrictions set forth above. The undersigned acknowledges and agrees thatHD DANCE INC may revise its procedures at any time based on updated recommended guidance and protocols issued by the Public Health Agencies and further, agrees to comply with HD DANCE INC's revised procedures prior to utilizing the facilities, services, and programs of HD DANCE INC. The undersigned further acknowledges and agrees that, due to the nature of the studio, services, and programs offered by HD DANCE INC, social distancing of 6 feet per person among children and adults.

The undersigned fully understands and appreciates both the known and potential dangers of utilizing the studio, services, and programs of HD DANCE INC and acknowledges that use thereof by the undersigned and/or such participating children may, despite the HD DANCE INC's reasonable efforts to mitigate such dangers, result in exposure to COVID-19, which could result in guarantine requirements, serious illness, disability, and/or death.



I AGREE THAT IN FURTHER CONSIDERATION OF BEING PERMITTED TO ENTER HD DANCE INC FOR ANY PURPOSE INCLUDING, BUT NOT LIMITED TO, OBSERVATION OR USE OF FACILITIES OR EQUIPMENT, OR PARTICIPATION IN ANY ON-SITE OR OFF-SITE PROGRAM AFFILIATED WITH HD DANCE INC, THE UNDERSIGNED HEREBY AGREES TO THE FOLLOWING:

THE UNDERSIGNED, ON HIS OR HER BEHALF AND ON BEHALF OF SUCH PARTICIPATING CHILDREN, FAMILY, SPOUSE, ESTATE, EXECUTORS, ASSIGNS, HEREBY RELEASES, PERSONAL REPRESENTATIVES, WAIVES, DISCHARGES AND COVENANTS NOT TO SUE HD DANCE INC, its directors, affiliates, officers, volunteers, agents, employees, and owner from all liability to the undersigned or such participating children and all personal representatives, assigns, heirs, and next of kin of the undersigned or such participating children for any loss or damage, and any claim or demands on account of any property damage or any injury to, or an illness or the death of, the undersigned or such participating children (or any person who may contract COVID-19, directly or indirectly, from the undersigned or such participating children) whether caused by the negligence, active or passive, of the HD DANCE INC or otherwise while the undersigned or such participating children are in, upon, or about the premises or any facilities or equipment therein or participating in any program affiliated with theHD DANCE INC. The undersigned expressly and knowingly waives all rights under California Civil Code Section 1542, which provides: "A general release does not extend to claims that the creditor or releasing party does not know or suspect to exist in his or her favor at the time of executing the release and that if known by him or her, would have materially affected his or her settlement with the debtor or released party."

I AGREES TO INDEMNIFY AND SAVE AND HOLD HARMLESS HD DANCE INC, its directors, officers, employees, volunteers and agents, and each of them, from any loss, liability, damages or costs they may incur, whether caused by the negligence, active or passive, or otherwise while the undersigned or any participating child is in, upon, or about the premises or any facilities or equipment therein or participating in any program affiliated with HD DANCE INC. The undersigned understands and agrees that HD DANCE INC is not required to provide insurance to cover the undersigned or such participating children in the event they suffer an illness, injury, death, property loss, theft or damage of any sort upon, or about the premises or any facilities or equipment therein or participating in any program affiliated with HD DANCE INC.HD DANCE INC defend from and against any and all costs, expenses, damages, claims, lawsuits, judgments, losses, and/or liabilities arising either directly or indirectly from or related to any and all claims made by or against any of the Released Pares due to bodily injury, death, loss of use, monetary loss, or any other injury from or related to my use of HD DANCE INC Facilities, tools, equipment, or materials, whether caused by the negligence of the Released Pares.

HD DANCE INC endeavors to provide safe, effective, and high-quality programs but makes no warranty or guarantee that specific services, products, methods, workouts, recommendations, or routines will be safe, effective, or suitable for everyone.

Since dance and fitness classes/programs/events/instruction may involve strenuous physical activity, we highly recommend having a physician's approval prior to participating. By electing to take part in our live or virtual programs, you either have obtained such approval or accept the risk inherent in engaging in physical activities. TUITION / PAYMENT & NO REFUND POLICY

- 1. Tuition: Tuition is due by the 1st of each session. We accept credit card on AutoPay which will charge your card automatically on the 1st of each session. If you're utilizing the online registration, payment will be processed immediately. All families with students enrolled in on-going classes MUST have a valid credit card on file with the front desk regardless of their decision to use Auto Pay. Autopay can only be canceled by contacting our front office Please see "DROPPING A CLASS" below for more info.
- 2. Late Fee: Tuition that is not paid by the 1st of each session, is considered LATE. You may pay for classes early if you know that you will miss the first week of class. If tuition is not paid by the 1st of any given session, a late fee of \$10 will be assessed. If tuition is not paid by the 5th of any given session, a late fee of \$25 will be assessed and the student will not be allowed to participate in any further classes until tuition and late fees are paid in full. After the 5th, your credit card on file will be charged. Note: you will be notified by email and given 48 hours to submit payment before the credit card is charged. Please note that the first late fee will be assessed during this 48 hours of time given to submit payment.
- 3. Refund Policy: There are **NO REFUNDS OR CREDITS** that will be given for tuition, registration fee, recital tickets, recital costumes, and any tuition related fees.
- 4. Registration Fee: Our annual registration fee of \$30/family is assessed every August. If this fee is not paid by the tuition due date (August 15th of each year), then your child will be dropped from their class. This is a non-refundable fee. Please note that if your card is on auto-pay with us, this fee will automatically be taken out on the 7th with your child's tuition.
- 5. Pro-rating: We do prorated classes for new students who are enrolled after the session started..
- 6. Returned Checks: Any check that is returned will be subject to \$25 fee.
- 7. Cancelation of classes: I understand and agree that HD Dance INC reserves the right to cancel any or all classes. Should a class be cancelled, we will provide an acceptable replacement.



STUDIO CLASS GUIDELINE

I hereby agree to the guidelines set forth in following

CLASS RULE & ETIQUETTE

Dress Code: Ballet:Leotard uniform will be assigned to each student along with ballet pink tights, black/ pink leather ballet slippers. No jewelry or watches. Small, non-dangling earrings are permitted. Hair should be pulled back neatly from the face and secured. For boys ballet: Fitted white T-shirts, black tights held in place by a belt rolled with the tights at the waist, dance belt, white socks, and white ballet shoes. Hip-Hop/KPOP/Fitness: Comfortable clothes with closed toe shoes.
